3 Introduction of Commissioners

The newly appointed commissioner, Megan Reichert, introduced herself as well as all attending commissioners.

4 Public Comment

5 Capital Southeast Connector JPA- Derek Minnema, Executive Director

Capital Southeast Connector JPA was formed in 2006 for the sole purpose of completing the project of a 34 mile expressway (high speed, spacing of signals, access controlled, and 30 feet of space between the class 1 bike path) designed to

link I-5, SR 99 and US 50 all around the Sacramento region. Benefits include reduced congestion and VMTs, and improved safety. Eleven miles are completed with 9 more miles currently under design.

Projects completed include modernization of Kammerer Road, Grant Line/Union Pacific overhead project and the Silva Valley Parkway interchange. Projects underway include Kammerer Road Extension, Grant Line Road Safety and Freight mobility and White Rock Road Expressway Phase 2. Aggregate trucks are some of the heaviest freight trucks using this expressway.

The JPA has prepared a comprehensive project status report which is reviewed by an independent Taxpayer Oversight Committee establish by voters approving measure A.

This project involves 3 congressional districts, 3 supervisorial districts and 5 regional cites. Bipartisan support of the project has been essential to prioritizing the Connector with SB 1 funds.

The bike path is part of the Sacramento regional trail network. There are no restrooms or water along the bike path. Cities may consider adding these amenities to sections that intersect their jurisdiction. The bike path is on the "developed" side of the road. An upcoming project is gap closure of the bike trail, so it goes by the state park in Rancho Cordova, with Aerojet is on the opposite side of the street. There will be a crosswalk at each light.

Because many of the roads in the connector corridor are up to 60 years old, their uses no longer align with the purpose they were intended for. Sharps curves are being eliminated and reconstructed with gradual curves to accommodate a higher speed and standard 8 foot shoulders are being added. Safety needs that the new connector addresses are proper drainage, clear recovery, and standard shoulder widths. Aggregate trucks are some of the heaviest freight trucks using this expressway.

- 6 Sacramento County Sustainability Update- John Lundgren, Sustainability Manager Sustainability dashboard will be updated in time for Earth Day. Includes six months of climate action plan actions. AB 306 is a wildfire package originating in So Cal but the impact to Sacramento would be the prevention of adopting reach codes for the next six years. Reach codes are the most significant method for Sacramento to reduce GHGs outside of carbon farming. John announced his retirement for the end of June 2025.
