Local Enforcement Agency (LEA)

The **Environmental Compliance Division** has been certified by the California Department of Resources, Recycling and Recovery (CalRecycle) as the **Local Enforcement Agency (LEA)** for Sacramento County. The LEA enforces state laws pertaining to the storage, processing, and disposal of solid waste.

The LEA permits and inspects solid waste facilities to ensure compliance with State Minimum Standards, inspects refuse collection vehicles operating in the County, and responds to complaints about illegal dumping and public nuisances caused by solid waste facilities.

Solid Waste Facilities regulated by the LEA include

- Active and Closed Landfills
- Transfer Stations
- Composting Facilities
- Wood and Green Waste Chip and Grinding operations
- Construction, Demolition, and Inert Debris Processing Facilities

Local Enforcement Agency (LEA)

Authority for EMD to act as the LEA is found in

- Division 30 of the Public Resources Code (PRC), section 43209, and
- Title 14 of the California Code of Regulations (14 CCR), sections 18051 and 18084

LEA Program Implementation

- Inspection and investigation of solid waste collection, handling, and storage, solid waste facilities, operations, and disposal sites and equipment to verify compliance with the state minimum standards, solid waste facilities permits, and related state solid waste laws and regulations within their purview for the protection of the environment and the public health and safety
- Investigations of illegal dumping and public nuisance complaints
- Processing of permit applications and closure/postclosure plans
- Enforcement as required by PRC Division 30; 14 CCR Division 7, Chapter 5, Article 4; 27 CCR, Division 2, Subdivision 1

LEA Billing

Section 6.99 of the Sacramento County Code (SCC) describes the fee structure for all EMD programs including the Solid Waste/LEA program. There are 3 fee components to the solid waste program:

- 1) Permit Fee: an annual facility fee based on facility type
- 2) Regional Fee: a share of the program costs, distributed based on the percent of the total County-wide tonnage received by solid waste facilities each quarter
- 3) Exceptional Hours Fee: billed at the EMD hourly rate, incurred when facility-specific staff time exceeds the hours covered by the permit fee

The Regional Fee fluctuates depending on program budget. For fiscal year 2022–23 the Regional Fee was \$240,000 (\$60,000/quarter). Starting January 2024, the Regional Fee will be \$280,000 (\$70,000/quarter). If proposed fees are approved, EMD expects the Regional Fee to decrease in time.

Proposal to Increase Fees

- EMD does not receive General Funding
- At least 10 years since last fee increase; fee study completed in 2023
- Proposed EMD Hourly Rate increase from \$213 to \$232 to be effective July 2024; last increase was in 2010
- The rest of the proposed fee increases will be phased in over 2 years
- Starting July 2025, fees may increase annually pursuant to the US Western Region Consumer Price Index (CPI)
- Hours per permit will be set based on the fee study
- EMD anticipates conducting another fee study in 2 years, and then every 5 years after that

LEA Fee Comparison

LEA jurisdictions can have different ways of billing their solid waste facilities, based on one or more of the following:

- Dollar amount per ton
- Hourly rate
- Permit fee
- Share of program cost (e.g., Regional Fee)

Jurisdictions included in the fee comparison are either nearby or of a similar size.

The following charts calculate a sample of what a facility would be billed for permit fee and tonnage fees as applicable if it were operating in the listed jurisdiction, based on its reported tonnage. Calculations for Active sites include a portion of the Regional Fee:

- Current Sacramento includes a portion of the \$240,000 Regional Fee.
- Proposed Sacramento includes a portion of the \$280,000 Regional Fee.

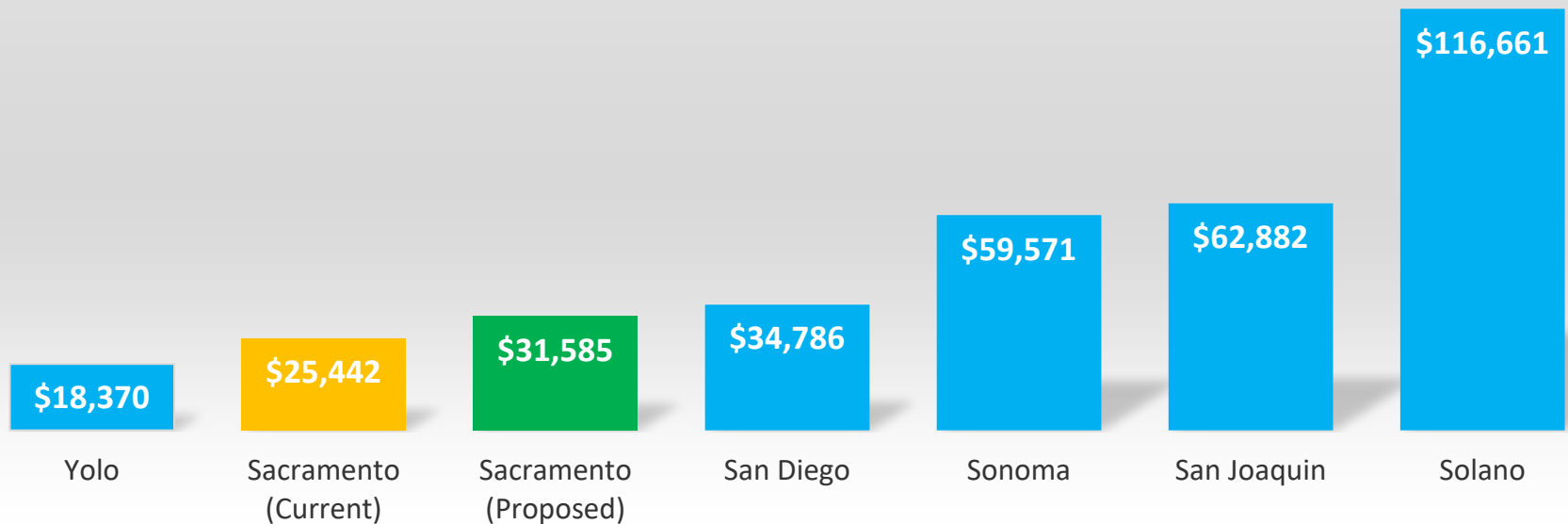

5% of the total tonnage received

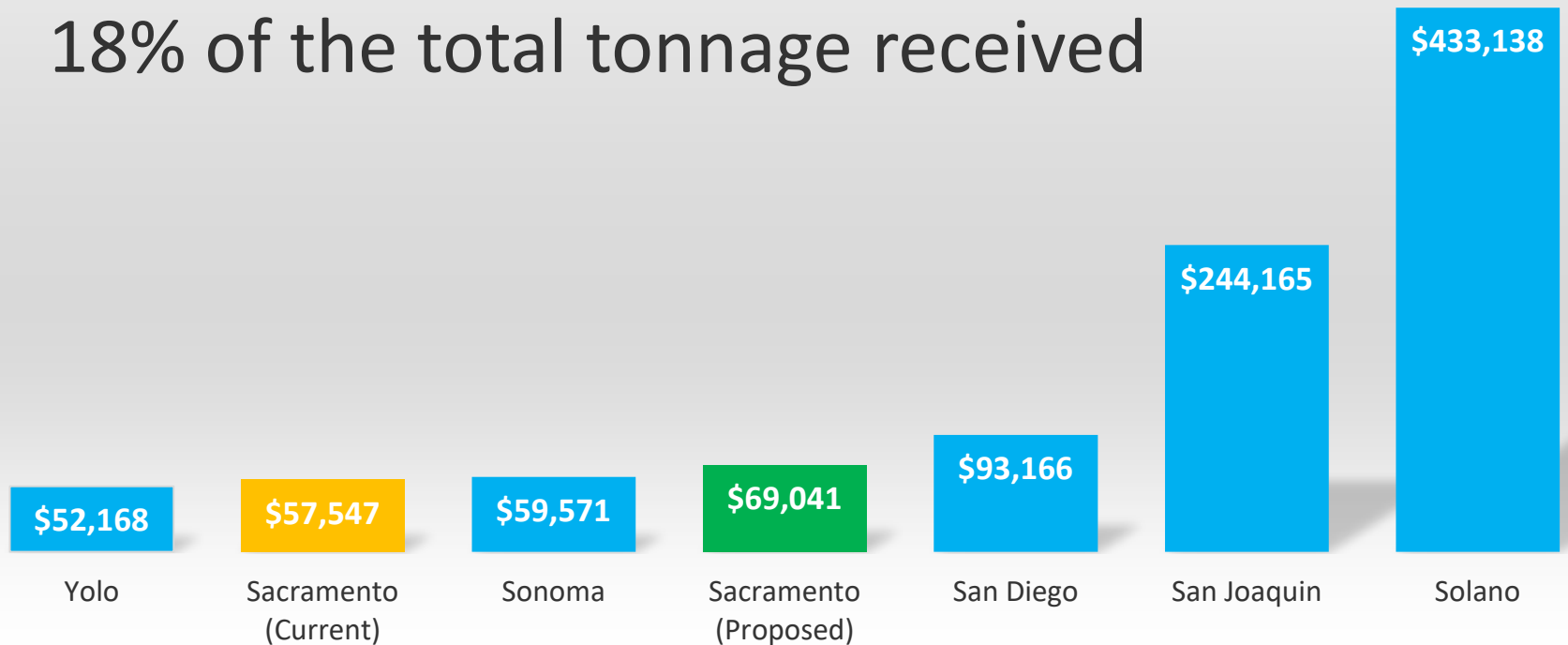


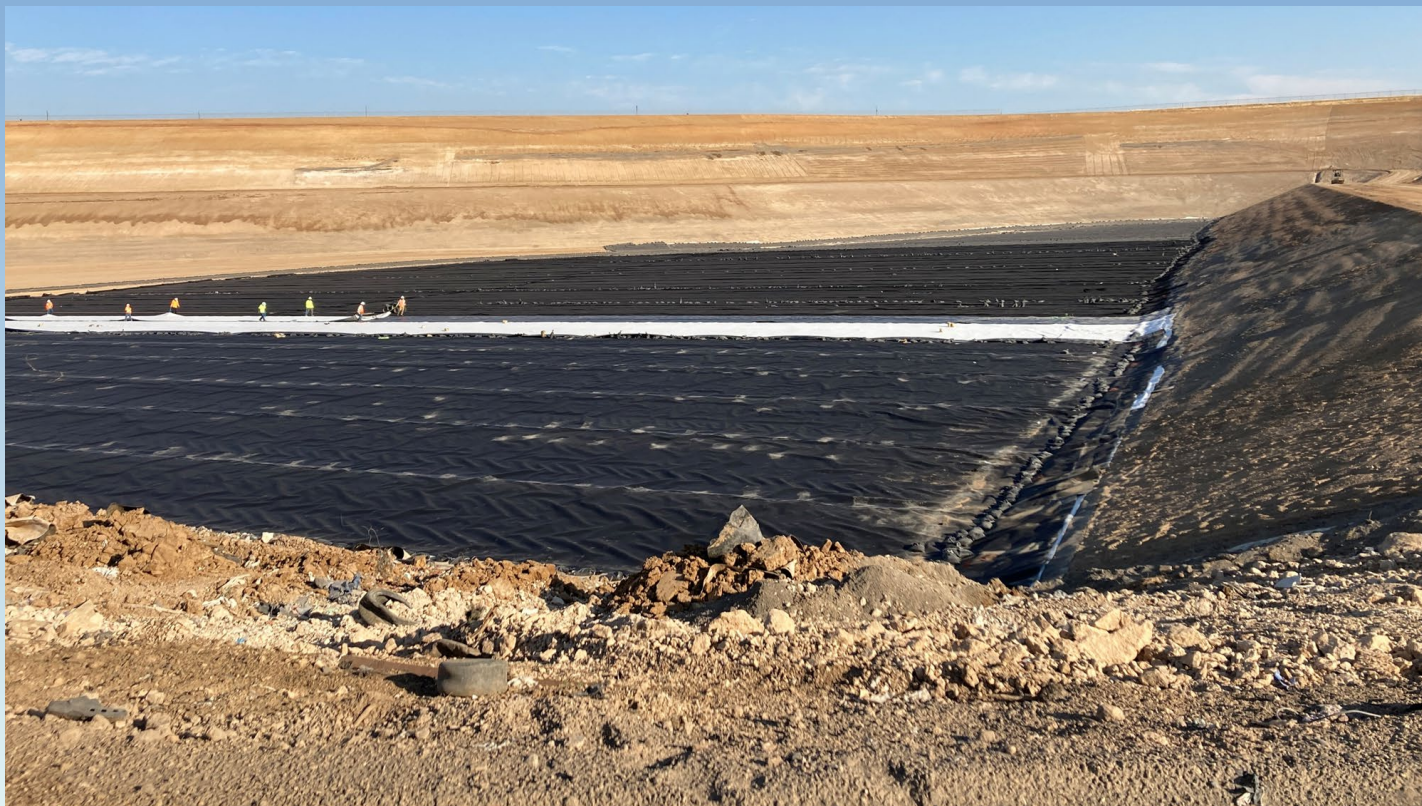

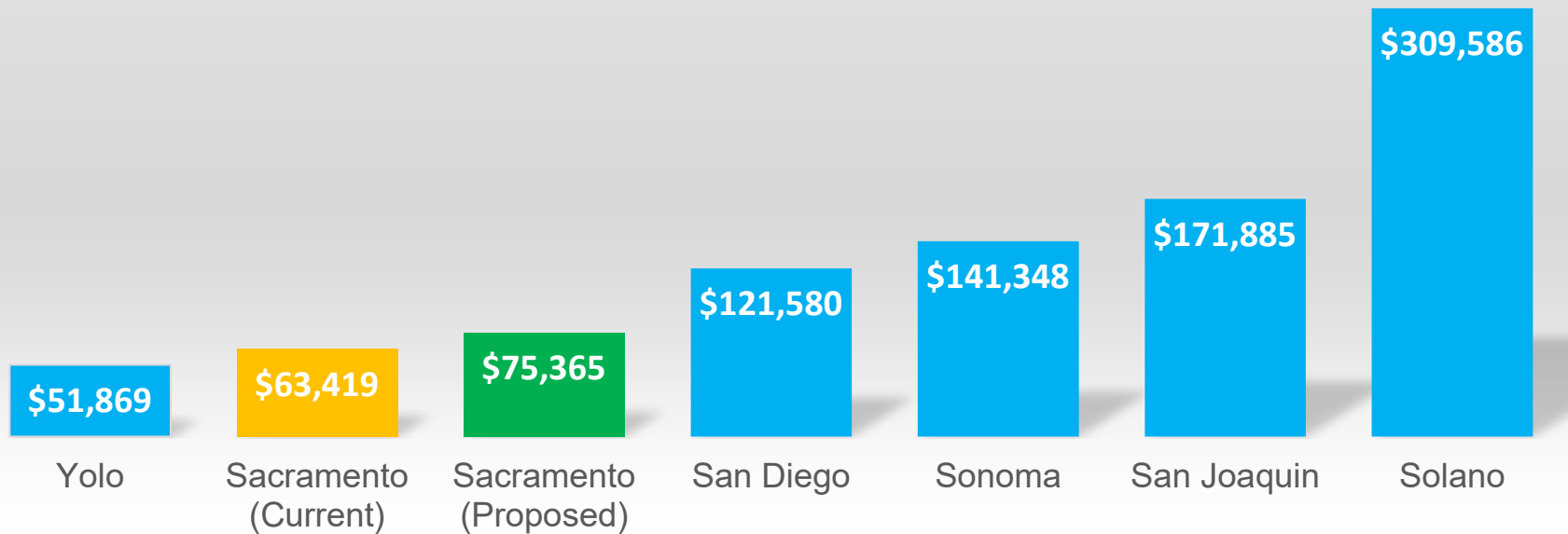
Solid Waste Landfill

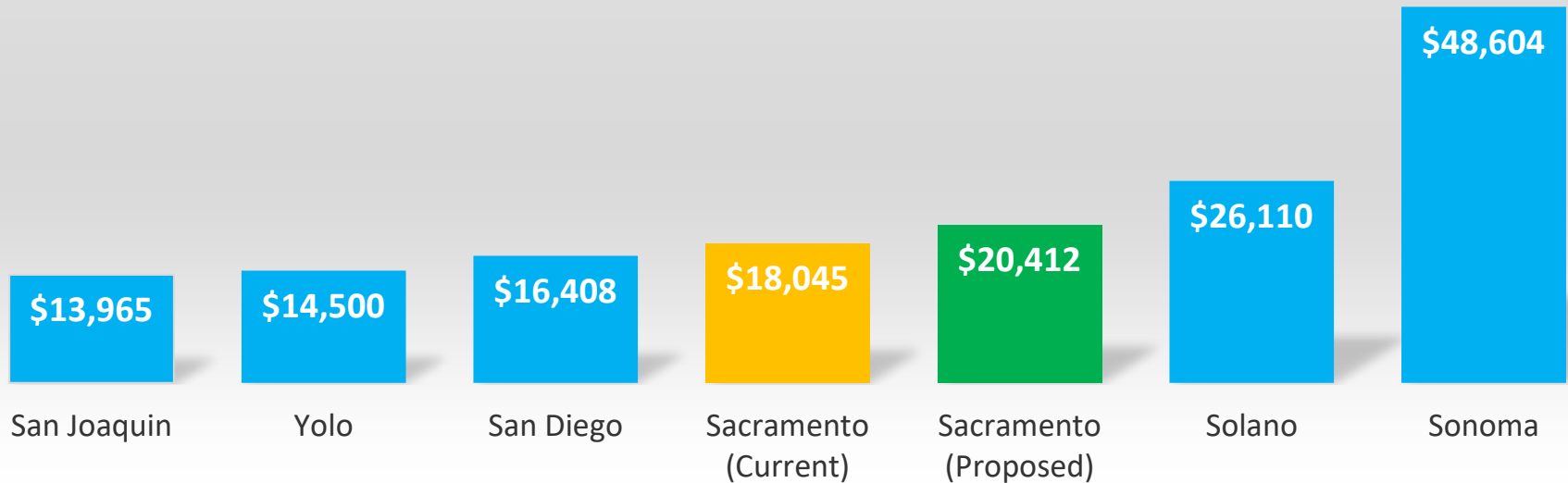

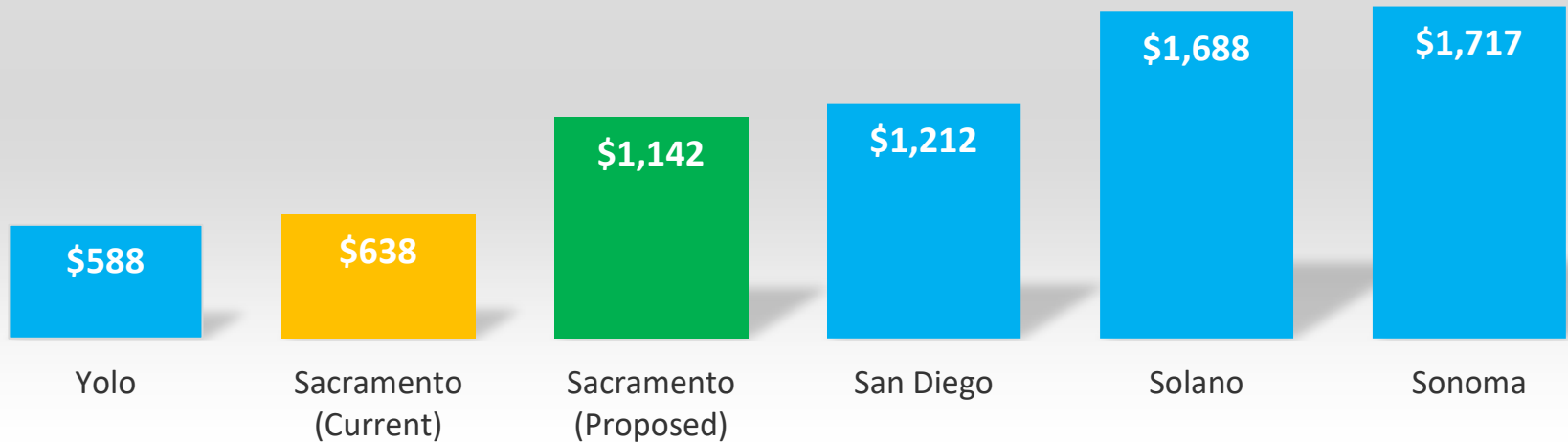

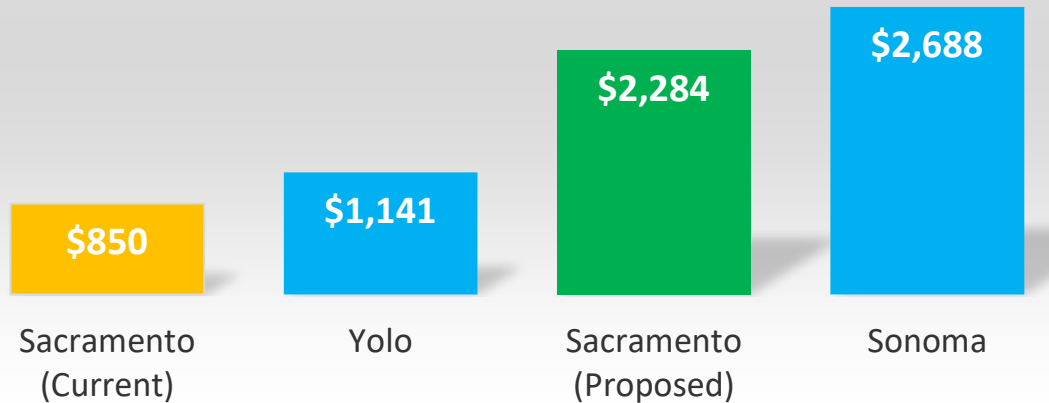

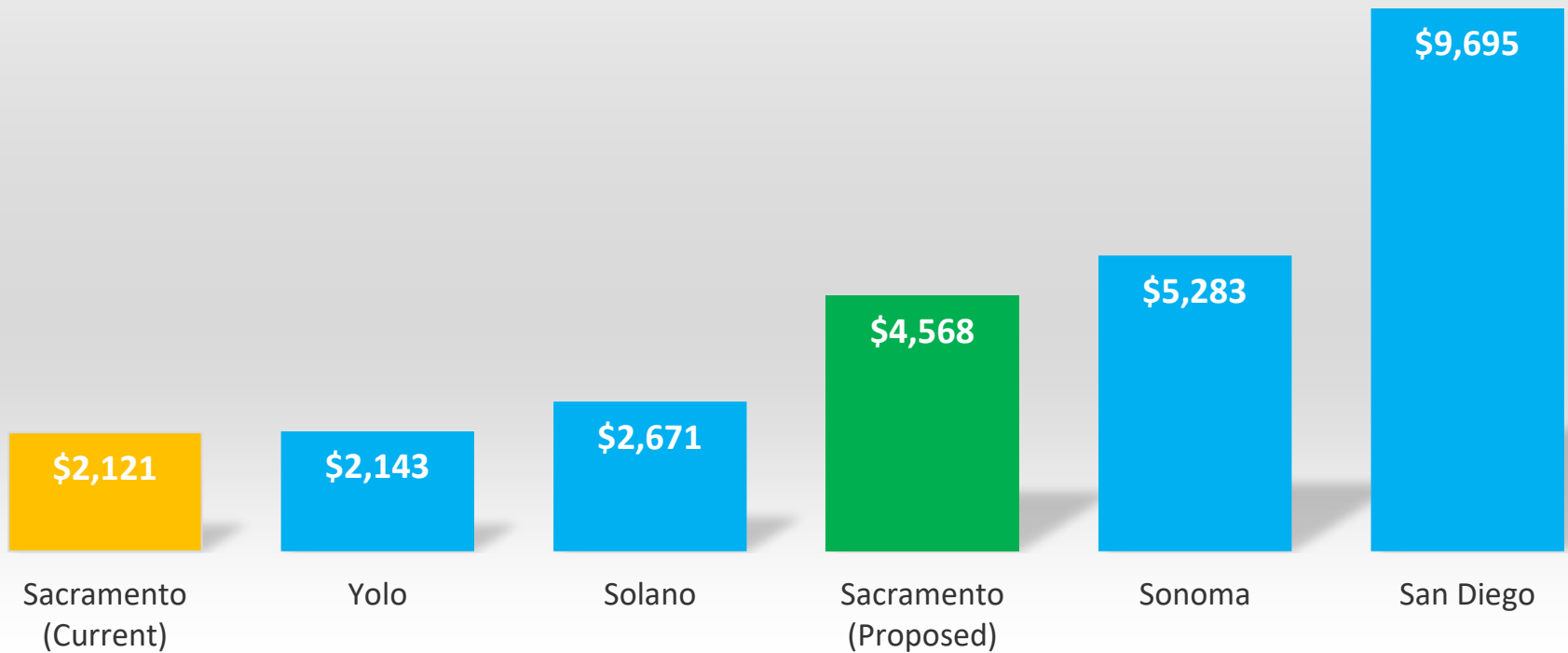

Proposed Program Fees for 2024-2026

The Environmental Management Department (EMD) does not depend on general funds for the administration of our programs, so EMD must recover 100% of the cost of program and support staff through fees.

Due to increased cost of living rates as well as costs associated with implementing new and existing State mandated programs, EMD recently conducted a permit fee schedule review. Despite the incorporation of efficiency measures increased costs will require adjustments to existing fees.

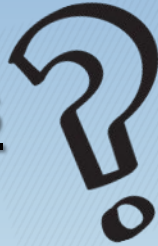
