Introduction

Please be advised that the Sacramento County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) Amendment application for Elder Creek Transfer and Recovery to revise the facility's Transfer Processing Report (TPR). The LEA is certified by the State of California Department of Resources, Recycling, and Recovery (CalRecycle) to enforce state

laws and regulations at solid waste sites within the County and City of Sacramento, including transfer stations.

Description of project and LEA's determination

Elder Creek Transfer and Recovery (ECTR) is a large volume transfer station located at 8642 Elder Creek Rd in Sacramento, CA 95828. On September 30, 2022, the LEA received an RFI amendment application package to revise the TPR in order to address the installation of an outdoor canopy and mechanical green waste sort line on the east side of the building in an area that is currently used for the unloading and physical sorting of the source separated organic green container waste stream created by SB1383. ECTR will also be installing two Fire Rover systems to better address potential fires in material on the indoor tipping pad, and constructing a large stormwater retention pond in the front grass area immediately south of the front entrance gate along Elder Creek Road. Minor updates were also made to the Emergency Contacts list and Equipment Inventory list. The TPR revisions were accepted by the LEA on October 27, 2022.

The LEA found the proposed changes to be consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents and applicable State Minimum Standards, and do not conflict with the terms and conditions in the current Solid Waste Facility Permit.
