**Introduction**

The Sacramento County Environmental Management Department (EMD) is certified by the California Department of Resources, Recycling, and Recovery (CalRecycle) to act as the Local Enforcement Agency (LEA) within the Cities and County of Sacramento. The LEA issues permits and enforces state laws and regulations at solid waste facilities. Please be advised that the Sacramento County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) Amendment application to the Solid Waste Facility Permit for the Florin Perkins Public Disposal Site MRF/LVTS.

**Description of project and LEA's determination**

The Florin Perkins Public Disposal Site MRF/LVTS is a large-volume transfer station and material recovery facility located at 4201 Florin Perkins Road, Sacramento, CA. 95826. This facility is permitted by the LEA to receive 500 tons per day of source separated inert debris and 500 tons per day of all other waste. The facility's permitted traffic volume is 258 vehicles per day counted in one direction.

On February 14, 2024, the LEA received an application package to amend the facility's current RFI in order to change the facility's name and update ownership information.

The LEA found the proposed changes to be consistent with the project description, compliant with applicable California Environmental Quality Act (CEQA) documents, compliant with applicable State Minimum Standards pursuant to California Code of Regulations, Titles 14 and 27, and compliant with the conditions outlined in the current Solid Waste Facility Permit.

The LEA accepted the application and approved the RFI amendment on February 29, 2024.
