Introduction

Please be advised that the Sacramento County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) Amendment application for Elder Creek Transfer and Recovery to revise the facility's Transfer Processing Report (TPR). The LEA is certified by the State of California Department of Resources, Recycling, and Recovery (CalRecycle) to enforce state

laws and regulations at solid waste sites within the County and City of Sacramento, including transfer stations.

Description of project and LEA's determination

Elder Creek Transfer and Recovery (ECTR) is a large volume transfer station located at 8642 Elder Creek Rd in Sacramento, CA 95828. On November 30, 2023, the LEA received an RFI amendment application package to revise the TPR to allow site design changes to accommodate the addition of Electric Vehicle (EV) charging stations. ECTR proposes to install eight (8) EV charging parking spaces with all necessary electrical infrastructure and parking lot reconstruction. The amendment also includes minor updates which consist of identifying the soil stockpile located at the front of the property left over from the stormwater retention pond installed during the last TPR amendment, updates related to site personnel information, and a new perimeter electric fence which is to be installed within 2' of the existing chain link fence around the perimeter of the site. The TPR revisions were accepted by the LEA on December 21, 2023. The LEA found the proposed changes to be consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents and applicable State Minimum Standards, and do not conflict with the terms and conditions in the current Solid Waste Facility Permit.
