The Business Environmental Resource Center (BERC) within Economic Development offers free consultation to assist business with navigating permitting and compliance

with local regulations.. There is a Sustainable Business Program within BERC to promote and recognize businesses that are committed to environmental sustainability. Approximately 800 local businesses have been certified as sustainable by Economic Development over the lifetime of the program. Certification criteria includes water conservation, air quality and transportation, pollution prevention, energy conservation, green design, and waste reduction. Program incentives are recognition, access to business rebates and incentives based on industry, and networking opportunities.
