AB 2524 Catering Operations and Host Facility went into effect January 1<sup>st</sup>, 2019. Kelly McCoy reviewed the provisions of the new law with the SEC members. This law modifies the California Retail Code by adding definitions for "Host Facility" and "Catering Operation" creating a pathway for breweries and wineries to apply for Host permits which in turn would allow food businesses to prepare and sell food at the facilities for up to four hours in a 12 hour period. Host facilities must meet basic requirements such as approved restroom with handwashing sink, refuse storage, liquid waste disposal and compliance with zoning codes. The catering operations must comply with the list of approved limited food preparation activates and submit a standard operating procedure including a list of foods being served and methods for maintaining food safety and sanitation.

EMD conducted outreach workshops to industry, primarily breweries and wineries. Industry expressed support for the new legislation and did not express any concerns or negative feedback.

EMD would present to the Board of Supervisors a revised ordinance requesting new permit and fee categories.

A motion in support of compliance with AB 2524 provisions, including new permit and fee categories, was made by Mark White and seconded by Diane Kindermann.
