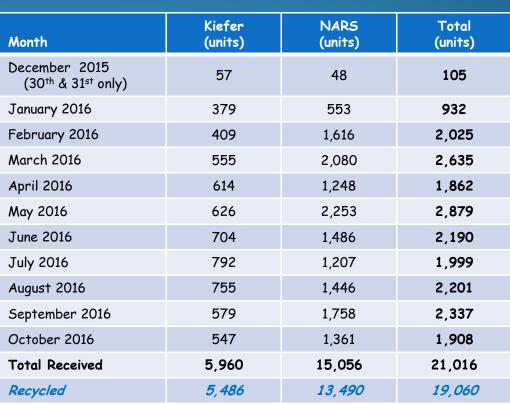


Mattress Program

- Assembly Bill 254 (Hancock & Correa)
- Signed by Governor on September 27, 2013
- Board approved contract with MRC on December 15, 2015
- ByeBye Mattress program commenced on December 30, 2015

- Senate Bill 20 & 50 (Sher 2003 & 2004)
- · Covered Electronic Waste (CEW), Universal Waste Electronic Devices (UWED) State
- Recyclable Electronic Equipment Materials (REEM) Sacramento County
- Contracted with processor in September 2009 Fixed Price structure
- Restructured contract with processor in August 2015 Market Based structure

- AB 1843 (1989) established the Tire Recycling Act
- Current State tire recycling fee at point of sale is \$1.75/tire to fund the statewide program
- First 4 car and light truck tires free at County facilities starting in October 1990
- Recent cost increase due to changes in market conditions

Paint Program

- Assembly Bill 1343 (Huffman)
- Signed by Governor on September 28, 2010
- County executes a no-cost contract with Visions Paint Recycling on May 28, 2013
- Board approved amended contract with Clean Harbors on June 18, 2013
- PaintCare Program begins at County ABOP & HHW facilities on July 1, 2013
- Reuse reimbursement program with PaintCare begins August 2013

Green Waste Program

- Residential Green Waste was implemented in February 1997
- The County's first contractor processed the green waste materials from February 1997 to April 2002 under a unit bid price cost structure
- From April 2002 until March 2006 the materials were processed by a different contractor,
 still under a unit bid cost structure
- The Biomass Fuel Blend pilot project began in March 2006.

- Single Stream Recycling was implemented in April 1998
- The County's first contractor processed the single stream materials from April 1998 to February 2006 under market based structure
- From March 2006 until February 2013 the materials were processed under a fixed price structure
- Currently, processing occurs under a market based price structure

- Bulky Waste Clean-Up or NCU was implemented in 1990
- Regular annual NCU was changed to Appointment Based NCU (ABNCU) in March 2006
 Reduced illegal dumping in NCU scheduled areas
 Reduced scavenging of pile s put out for NCU collection
- Some material diverted from NCU program, but most disposed
- Contracted with a local processor for the processing of NCU material in July 2014 at a cost of \$38.00/ton with a guarantee of 75% diversion

Organics Recycling

- Green Waste
- Food Waste
 - AB 1826 Commercial Food Waste (SWA)
 - Collected by SWA franchised haulers
 - Materials managed by private sector infrastructure
 - Residential Food Waste (County)
 - On the planning horizon
 - Not currently on the regulatory horizon
 - Higher contamination of material expected to process locally, would need new local processing infrastructure or send to processing facility outside of the county
