## COMPLIANCE ASSISTANCE, WORKSHOPS AND OUTREACH

#### How To Get A Green

One "How To Get A Green" workshop was held with six participants in attendance.

#### Hazardous Materials Business Plan (HMP) Workshops

One HMP workshop was held with two businesses in attendance.

#### Food Safety Education (FSE)

Four FSE classes were conducted in December with a total of 26 participants representing 8 facilities. Two classes were conducted in Spanish, one class was conducted in English and one class was conducted in Cantonese.

#### Northern California Korean Dry Cleaners Association

Environmental Specialist (ES) Doug Osborn met with members of the Northern California Korean Dry Cleaners Association to discuss hazardous waste issues. Topics of discussion included dry cleaning equipment, reduction in hazardous waste generation and hazardous waste inspections/compliance.

#### PROCESS IMPROVEMENT AND COLLABORATION

### California Conference of Directors of Environmental Health (CCDEH)

EMD Director Val Siebal and Environmental Health Division Chief John Rogers attended a meeting of the CCDEH. Representatives from the California Department of Public Health, the California Department of Food and Agriculture, and the California Environmental Protection Agency shared information regarding produce stands, body art and the California Environmental Reporting System.

#### Sacramento County Agricultural Commission

Environmental Specialists (ES) Rebecca Knoche and Jeni VanDusen presented training to Sacramento County Agricultural Commission staff regarding hazardous materials, hazardous waste and above ground storage tanks. Commission staff will utilize the information when performing regulatory compliance inspections at farms on behalf of EMD's Environmental Compliance Division.

### Anaerobic Digester Research Project

Supervising ES Lisa Todd and ES Lea Gibson met with representatives from Atlas Disposal Industries, Clean World Partners and the county Department of Waste Management and Recycling to discuss the installation of an anaerobic digester at the South Area Transfer Station. The anaerobic digester would convert green waste and restaurant food waste to liquefied natural gas (LNG) which would be used to power refuse vehicle.

### EMPLOYEE TRAINING

#### Biology And Control Of Vectors Presented By Centers For Disease Control And Prevention

EMD Director Val Siebal welcomed instructors from the Centers for Disease Control and Prevention who provided a two-day training course on the Biology and Control of Vectors. Attendees received information on the various characteristics and habitats of many common vectors, including cockroaches and bed bugs encountered during environmental health inspections. The principles of Integrated Pest Management were also reviewed during the training. Several environmental health staff from counties throughout the state attended the training.

#### 2011 Natural Gas Pipeline Awareness Workshop

ES Robert Duncan participated in the 2011 SMUD (Sacramento Municipal Utility District) Natural Gas Pipeline Emergency Response Awareness Workshop and Tabletop Exercise. Exercise participants included representatives from SMUD, State Department of Fish and Game, Sacramento City Fire Department, Yolo County Environmental Health Department, California Highway Patrol, Federal Bureau of Investigation, Transportation Security Administration, California Department of Forestry and Fire Protection, and Pacific Gas and Electric Company.
