NEWS MEDIA INTERACTION

Food Safety Tips For Halloween

Environmental Health Division (EHD) Chief John Rogers was interviewed by Kitty O'Neal, News Radio KFBK 1530 regarding food safety tips for Halloween. Chief Rogers provided suggestions which included serving children a meal before trick or treating; not allowing children to eat candy before it is checked by parents; and allowing children to only eat factory-wrapped treats unless the provider is known.

COMPLIANCE ASSISTANCE, WORKSHOPS AND OUTREACH

Food Safety Education (FSE)

Five FSE classes were conducted in October with a total of 82 participants representing twenty facilities. Two classes were conducted in English, one class was conducted in Spanish, one class was conducted in Cantonese, and one class was conducted in Vietnamese.

<u>California Environmental Reporting System/Hazardous Materials Business Plan Workshops</u>
Two workshops were provided to business owners and operators to assist with online electronic reporting of hazardous materials business plans. Fifteen people representing fourteen separate businesses participated in the workshops.

Childhood Lead Poisoning Prevention Program (CLPPP)

EMD's CLPPP presented an educational exhibit in the lobby of the Sacramento County Administration Building from October 20 to October 26, 2013 in observance of Childhood Lead Poisoning Prevention Week. The exhibit focused on keeping homeowners safe from lead contaminated paint, dust, soil and other sources of lead. Outreach materials were also provided at over 70 public locations within the county, including home improvement and paint stores, public libraries, schools and government agencies. Notice was posted on EMD's Facebook page for owners of pre-1978 homes.

PROCESS IMPROVEMENT AND COLLABORATION

Sacramento Environmental Commission (SEC)

On October 21, 2013 Director Val Siebal and Executive Secretary Vicki Kloock provided staff support at the monthly SEC meeting. Dr. Olivia Kasirye, City/County Public Health Officer, provided an update regarding the flu season in Sacramento County and information on the progress toward national certification of the Public Health Division. Ruben Robles, Director of Operations, Sacramento Regional County Sanitation District, updated the Commission on the EchoWater Project and upgrades required by the recent National Pollutant Discharge Elimination System Permit. Allan Hirsch, Chief Deputy Director, Office of Environmental Health Hazard Assessment, presented information regarding a new California Communities Environmental Health Screening Tool (CalEnviroScreen 1.1) that can be used to help identify California communities that are disproportionately burdened by multiple sources of pollution.

2015 Sustainability, Secure and Safe Food Conference

EMD Director Val Siebal and EHD Chief John Rogers met with Juli Jensen, Sacramento County Agricultural Commissioner, to discuss the 2015 Sustainability, Secure and Safe Food Conference to be held in Sacramento. Ms. Jensen accepted an invitation to join the Conference Steering Committee and shared some excellent ideas.

Geothermal Heat Exchange Well Standards Advisory Group

Environmental Specialist (ES) Susan Williams represented the Water Well Technical Advisory Committee of the California Conference of Directors of Environmental Health at several meetings of the Department of Water Resources Geothermal Heat Exchange Well Standards Stakeholders Advisory Group. The Advisory Group will meet weekly until mid-November to fine tune the draft Standards for public review in early 2014.

Certified Unified Program Agency (CUPA)

EMD Director Val Siebal and County Agricultural Commissioner Juli Jensen met to review the CUPA contract and to identify potential issues. Commission staff will join EMD during industry outreach regarding Commission and CUPA fees.

Sacramento County Airport System

EMD Director Val Siebal, Environmental Compliance Division (ECD) Deputy Chief Marie Woodin, and EHD Chief John Rogers met with John Wheat, newly appointment Director of the County Airport System, to share information regarding EMD programs that intersect with Airport operations. The recent Mather Air Show was also discussed and Director Wheat was provided with a tour of the EMD building.

2013 World Aquatic Health Conference

Supervising ES Colleen Maitoza presented a seminar on Preventing Drowning and Other Injuries: Top Ten Model Aquatic Health Code Provisions at the 2013 World Aquatic Health Conference. Information provided included provisions related to lifeguarding and bather supervision, design and construction, chemical safety, ventilation and air quality, risk management and operator training.

TRAINING

Incident Command System (ICS) For Public Health Outbreaks

EHD Deputy Chief Kelly McCoy, Supervising ES Zarha Ruiz and ES Sonia Andrusiak received training regarding the use of the ICS by local agencies during disease outbreaks. Attendees received information regarding the development of an action plan, briefing implementation, and how the ICS might be organized for use during an outbreak. The training was presented by the Public Health Division of the Sacramento County Department of Health and Human Services.

Train the Trainer

EMD's Environmental Compliance Division hosted a Train the Trainer seminar sponsored by the CUPA Forum Board. The training focused on developing skills for presentations. Attendees received insight on learning styles, communication skills, and practical techniques for delivering quality presentations or training. EMD staff and representatives from other counties attended the training.
